24-039 To receive apologies from members of council and accept valid reasons for absence

Apologies for absence received and accepted from Cllr. Brett Lonsdale. Apologies for absence also received from District Cllr. Jon Bateman.

A letter has been received from David Atkinson, Director of Planning at Harborough District Council thanking the Parish Council for their comments regarding the accessibility of the recent Local Plan Ideas and Options Consultation.

24-046 To discuss speeding concerns

- The Parish Council is still waiting for Leicestershire County Council to provide some advice on a suitable location for an additional vehicle activated sign.
- The local Community Speed Watch Scheme requires a minimum of twelve volunteers who need to undergo training.
- Cllr. Crews has contacted the Leicestershire Police and Crime Commissioner to invite him to attend a meeting to discuss concerns.
- The busiest day for the Auto Speed Watch Device recorded 63 people speeding through the village.

24-047 To discuss matters arising at the cemetery

- The tree survey has been completed and circulated to the Parish Council for review.
- There has been a request for a bin nearer to the cemetery to try and reduce dog fouling. Harborough District Council will not allow us to add any bins to the current amount. Cllr. Parker suggested we could trial leaving the cemetery black bin out on the pavement to see if it gets used.

24-048 To discuss matters arising at the pocket park

- The Parish Council is aware that the Pocket Park is in need of a lot of maintenance and hope to hold a working party for volunteers.
- Cllr. Parker advised that a petrol lawn mower is now available and requested that a secure shed is purchased to keep equipment in.
- Stephen Morris offered to provide weedkiller and clear the hedge alongside the large gate entrance to allow vehicular access for future works.
- A quote has bee requested for the clearance of the brambles at the far end of the park behind the pond.
