Minutes of the Meeting of Swinford Parish Council held on Tuesday 3rd September 2024 at 7.30pm at Swinford Village Hall

24-101 To receive apologies from members of council and accept valid reasons for absence No apologies for absence received.

PUBLIC PARTICIPATION SESSION (15 minutes)

24-103 To adjourn the meeting for contrbutions from members of the public(*To allow the public to make representations, ask or answer questions, give evidence relating to the business being transacted in accordance with the Public Participation Policy agreed at the meeting held on 04.04.17 minute reference 17-69*)

- A resident asked why the agenda wasn't on the noticeboard.
- A resident asked if the road sign erected at the junction with the A5 is correct. The name is Shawell Road. The Parish Council checked maps and it appears to be correct.
- A resident advised that signage at the junction of the A5 and Market Harborough Road directs traffic right to Swinford, the signage needs updating to direct traffic left.
- A resident advised that the footpath signs on Fir Tree Lane and Stanford Road have been replaced.
- Work has started on the Village Hall project, it is anticipated for completion by the end of September 2024. The next stage of the project will be the installation of solar panels. Cllr. Parker thanked everyone involved for their hard work in managing the project and obtaining the funding.
- It was noted that soil has been piled up on the bend on Stanford Road.
- It was noted that The Swift Flash has not been delivered to Swinford over the summer as there is no one to distribute it.
- A resident asked how much attention is given to soil substructures in planning applications. The resident believes there are water courses that have not been identified and requested that the Parish Council consider this when evaluating planning applications.

24-109 To discuss speeding concerns

- Speeding was at a high level during the weekend of The Long Road Festival at Stanford Hall.
- Cllr. Crews advised that Neighbourhood Link are running a survey, this could be used to report that speeding concerns in the village are still problematic.

- The Police and Crime Commissioner, Rupert Matthews, is going to attend the November Parish Council meeting to discuss concerns.
- A resident asked if the Parish Council could consider '20s Plenty' signs as displayed in Shawell.
- It was noted that there is also an increasing number of vehicles without MOT being picked up by the camera.

- There was a burial in the cemetery extension earlier today.
